#### SHIP.CARS EPOD PRIVACY NOTICE

### Last updated and effective January 18, 2018

Welcome to **ePod** (the "**Service**"). The Service is owned and operated by Ship.Cars USA, LLC, or one or more of its direct or indirect affiliates (collectively, the "**Company**", "**our**", "**we**", or "**us**").

We respect your privacy and are committed to protecting it through our compliance with this privacy notice (this "**Privacy Notice**") for the Service. This Privacy Notice describes the types of information we may collect from you or that you may provide when you download, install, use, register for, or utilize functionalities of, the Service, and our practices for collecting, using, maintaining, protecting, and disclosing such information. We have created this Privacy Notice in order to inform you of our firm commitment to safeguarding the privacy and security of information you provide.

Please read this Privacy Notice carefully before using the Service. We will treat any information we collect from you through any part of the Service in accordance with this Privacy Notice. By accessing or using any part of the Service (including when you click accept when presented with this Privacy Notice upon first opening the Service), you consent to all actions we may take with respect to your information in compliance with this Privacy Notice. If you are unwilling to accept the terms and conditions of this Privacy Notice, please do not use any part of the Service.

This Privacy Notice may change from time to time. Your continued use of any part of the Service after we make changes is deemed to be acceptance of those changes, so please check this Privacy Notice periodically for updates by navigating to the "Legal" page of the Service.

### 1. <u>APPLICATION OF THIS NOTICE</u>

This Privacy Notice applies to information collected through the Service, including the services provided via the Service and information exchanged by e-mail, text message, and other electronic messages between you and any part of the Service or the Company. This Privacy Notice also applies to any new internet properties we may acquire from time to time. This Privacy Notice will be updated accordingly. You may also check this Privacy Notice periodically for updates by navigating to the "Legal" page of the Service.

This Privacy Notice does not apply to information collected offline (unless such information was collected in furtherance of an order being processed via the Service) or through any other means, including any other website operated by any third party.

The laws of the United States and other countries might not be as comprehensive as those in your country, but please be assured that we take steps to ensure that your privacy is protected. By using the Service, you understand that your information may be transferred to our facilities, our affiliated companies, and to those third parties with whom we may share it as described in this Privacy Notice.

### 2. CHILDREN UNDER THE AGE OF 13

### 3. INFORMATION WE COLLECT

We collect several different types of information from and about users of the Service, including:

- information that is about you but does not identify you individually ("Anonymous Information"); and
- information by which you may be personally identified and is provided by you to us in certain areas of the Service ("Personally Identifiable Information").

We collect this information in several ways:

- directly from you when you provide it to us;
- directly from your employer, if applicable, when they provide it to us;
- automatically as you navigate through the Service (e.g., information collected automatically may include usage details, geolocation data, device ID, and information collected through other tracking technologies); and
- from third parties such as, for example, our business partners, carriers, brokers, shippers, service contractors and affiliates.

# 5. <u>PERSONALLY IDENTIFIABLE INFORMATION</u>

The Personally Identifiable Information we collect on or through the Service may include:

  - to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of assets of ours or of our subsidiaries or affiliates, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding in which Personally Identifiable Information about users of the Service is among the assets transferred;
  - o to fulfill the purpose for which you provide it;
  - o for any other purpose we may disclose when you provide the information; or
  - o otherwise with your consent.

We may also disclose Personally Identifiable Information if we are required to do so by law or if we in good faith believe that such action is necessary to (a) comply with any court order, law or legal process, including to respond to any government or regulatory request; (b) protect and defend our rights and property; (c) protect against misuse or unauthorized use of the Service; or (d) protect the personal safety or property of our users or the public. Please note that we might not provide you with notice prior to disclosure in such cases.

We may also disclose your Personally Identifiable Information to enforce or apply our Terms of Use https://ship.cars/terms-and-conditions-mobile and other agreements, including for billing and collection purposes.

## 7. TRACKING TECHNOLOGIES AND OPTING OUT

The Service utilizes technologies known as geo-tagging and/or geo-location. For example, photos taken through the Service are geo-tagged to provide more complete electronic proof of delivery information. Similarly, the Service may allow drivers to be geo-tracked so that carriers and shippers can more easily know where shipments are in real time.

We support the right of our visitors to choose. You have the ability to disable location-based tracking via your mobile device's settings application. ### 12. SPECIAL NOTICE TO CALIFORNIA RESIDENTS
